

Learning Plan 2021-2022*

Masks

- In compliance with Senate Bill 658, masks will not be required unless Carter County is declared a state of emergency and in consultation with the county and state health departments.
- If Carter County is declared a state of emergency, DPS will review its mask policy.

School Day

- We will be in-person and follow our district calendar for the year.
- We will monitor staffing and attendance to determine whether a districtwide shutdown is in the best interest of our students should Covid cases rise significantly.

Start Times

- School start times will remain the same as they were for the 20-21 school year.

Cleanliness

- Hand sanitizer will be easily found and encouraged to use in the hallways and each classroom.
- All classrooms will have disinfectant spray and/or wipes to utilize in helping to keep the classroom clean.
- Staff will spray down tables and chairs each evening with disinfectant.

Social Distancing

- Social distancing will be encouraged when space allows.
- Students will not be restricted to interacting with students in their specific classrooms.

Vaccinations and Testing

- Vaccinations are encouraged but not required for those eligible.
- While we do not require testing, we strongly encourage students and staff to take a COVID test whenever they are exhibiting COVID-like symptoms, especially if they have been in contact with someone COVID-positive.

Students w/ Disabilities

- Students with disabilities will be provided services based upon their IEP or 504 educational plan.

Parent/Teacher Conferences and IEP Meetings

- We will offer virtual PTC's and IEP's for parents/guardians who cannot or choose not to attend in person.

Visitors

- Meetings and volunteer workers are welcomed in the building.
- Visitors and guests will be allowed in the building for programs, concerts and other special events per pre-Covid policy.

Field Trips/Travel

- Field trips and travel will be allowed based on the restrictions that were in place pre-Covid.

Electronic Utility Bill Verification and Schedule Pick-up

- Utility bills can be submitted electronically and schedules can be sent out via email.
- Schools will be open at set times for students to find and visit their classes.

Contact Tracing

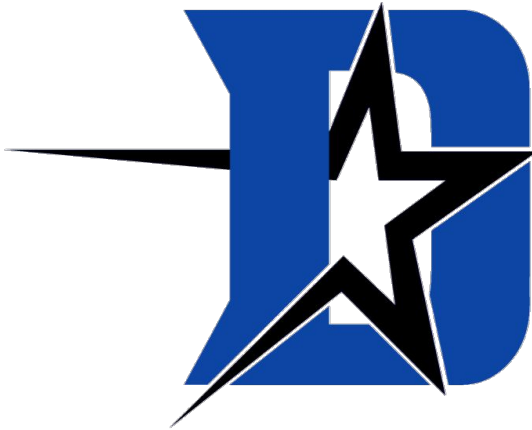
- Sites will track the number of positive Covid cases reported.
- Contact tracing will not take place unless directed by the county health department.

Remote Learning

- If a site is closed due to Covid positive cases, weather conditions or other extraordinary circumstances, remote learning will be instituted at the discretion of the district.
- PK-2 students will temporarily receive instruction via SeeSaw, 3-12 via Google Classroom and SPED according to their IEP.

Meal Service

- Breakfasts and lunches are free to all students for the 21-22 school year.
- Students will eat in the cafeteria.
- Guests at lunch will be limited to special occasions set by the school.
