	The Mountain View Whisman School District is authorized to confirm the authenticity of any documents provided where it has reason to believe false information has been provided on this statement or to any school/district official.
	I understand that unscheduled home visits and or/residency verification is part of a periodic process when residency is established in the Mountain View Whisman School District.
	The District may refer cases in which false information has been intentionally provided to the County District Attorney for further action and/or file civil action to recover damages incurred as a result of providing false information.
	Persons who provide false information are subject to criminal prosecution for perjury, which is punishable by a fine and/or a prison term. (Family Code Section 6553; Penal Code Section 118 & 126)
	Persons providing false information are civilly liable for fraud, negligent misrepresentation and negligence. Parties found civilly liable may be required to pay all damages caused to the District as a result of providing false information, as well as punitive damages. (Civil Code Section 1709)
