• **Special Needs Scholarship Program:**

- Act 55 creates a special education scholarship program under which students with disabilities, who have been denied from attending school in a nonresident district under the public school open enrollment program and attend a public school during the 2018-2019 school year, can attend a participating private school on the \$12,431 voucher. The Wisconsin Department of Public Instruction is currently developing more information on this program and will provide information as it becomes available.
